Narrative

On Friday March 23, 2012, I Cpl Gould assisted Deputy Marsha Sutphin on a traffic stop near the intersection of Cleveland Ave and Colonial Blvd. Upon my arrival to the scene, I found that Deputy Sutphin had stopped a white Mercedes Benz SUV. While talking to Deputy Sutphin she stated she observed the Mercedes make a right turn from Hill Street. As the Mercedes was making its turn, it exited the roadway in an unsafe speed causing the vehicles weight to shift drastically. The Mercedes proceeded into the center turn lane crossing over all three southbound lanes of Cleveland Ave. The Mercedes continued to travel south bound on Cleveland Ave traveling between all three lanes of southbound Cleveland Ave. The Mercedes then slowed down and drove up onto the sidewalk were it proceeded to travel until it made a right turn onto Colonial Blvd. Based on the erratic driving pattern of the Mercedes a traffic stop was made on the vehicle by Deputy Sutphin.

Deputy Sutphin approached the vehicle and made contact with the driver and sole occupant of the vehicle a white male. The driver was later identified as Robert Scott Jenks DOB 03/14/1981. When Jenks was asked if he knew why he was pulled over, he replied, "Probably because I was all over the road back there." When Deputy Sutphin asked Jenks on why he may have been all over the roadway, he replied, "Because I took to many muscle relaxers." While talking to Jenks Deputy Sutphin noticed, he was shaking uncontrollably and he had a difficult time speaking. At this time Deputy, request EMS to the scene to check on Jenks for any possible medical issues going on. Lee County paramedics arrived on scene and found Jenks to by in good health and not having any type of medical condition. While the paramedics where on scene, Deputy Sutphin asked Jenks of he ad taken anything else other then his muscle relaxers and Jenks replied, "I'm going to be honest with you, I was just leaving Babes because I hit a car. I just had to get out of there." Deputy Sutphin the found a small amount of damage to the bumper of Jenks vehicle. At this time fearing the Jenks maybe impaired I took over the investigation from Deputy Sutphin. Deputy Sutphin gave me a sworn written statement at the scene of the traffic stop. Deputy Vanegas who was also on scene responded to Babes to locate any possible evidence of a hit and run crash.

I then made contact with Jenks who was this time leaning on the back of his Mercedes. I identified myself. While talking to Jenks I noticed that he was unsteady on his feet and glassy eyes. Jenks had dilated pupils and very slurred speech. Jenks then admitted to taking muscle relaxers today. Based on my observations and fearing Jenks maybe impaired tonight he was asked if he would submit to field sobriety exercises and Jenks agreed to pre form the exercises. While walking to the area where the exercises were going to be preformed Jenks stated to me, "I'm going to fail it".

The first exercise was the horizontal gaze nystagmus. Jenks had equal tracking on both eyes and his pupils were dilated and equal in size. Jenks had a lack of smooth pursuit in both eyes and a distinct sustained nystagmus at maximum deviation. Jenks had a nystagmus prior to the onset of forty-five degrees. (35)

The second exercise was the walk and turn. During the instructions, Jenks could not keep his feet heel to toe. Jenks then started to walk and stopped before the start of the exercise. During the exercise, Jenks did not touch heel to toe on several steps and only took eight steps on the first set of nine. Jenks then made an incorrect turn used his arms for balance and never took the second part of the exercise. Jenks then stated to me "I can't do this. When I asked Jenks why he could not the exercise, his reply was "I'm messed up." At this time, the exercises were stopped for the safety of Jenks and he was placed under arrest for DUI. I read Jenks implied consent from a pre written card. [REDACTED]

I then made contact Deputy Vanegas who had returned from the parking lot of Babes. Deputy Vanegas was able to locate the bouncer who was identified as Evan W Brandt. Brandt states around 11:45 PM on March 22, 2012 a white Mercedes SUV drove into the parking lot of Babes and struck a parked truck. He then made contact with the driver who was wearing a plaid button up with jeans tattoos on his left arm and a hat. The same type of clothing Jenks was wearing when he was stopped by Deputy Sutphin. Jenks also has a large amount of tattoos on his left arm. While talking to the driver he was asked why he was shaking and the driver stated he was on muscle relaxers. At this point, Brandt asked the driver to parking his vehicle and he would get him a cab. The SUV then drove into another vehicle. Brandt asked the driver to park his vehicle, he would get him a cab or leave, and the SUV drove off. A sworn written statement was taken from Bandit by Deputy Vanegas and the drivers/ owner representatives of the two vehicles where located and there information was taken and crash investigation was completed. I then obtained a sworn written statement from Deputy Vanegas. Based on the information by Deputy Vanegas Jenks was also charged with three counts of DUI property damage and leaving the scene of a crash with property damage.

I then transported Jenks to the Lee County jail without incident. At the jail after twenty minute observation period in which Jenks did not burp vomit or place anything in his mouth he was given a breath test on the Intox 8000, Jenks breath results were .000 Br AC and .000 Br AC. Due to the low breath sample I read Jenks implied consent from a pre written card. [REDACTED] At the completion of my paperwork Jenks was unable to produce a urine sample. [REDACTED] I did not deem him a refusal because he was trying to produce a urine sample the entire time. I then turned Jenks over to the detention staff without incident.
