This letter is a follow up to several discussions Chief Bill Brooks and I have had with you regarding the conviction of Frederick Weichel for the 1980 murder of Robert LaMonica here in Braintree.

As you know, Chief Brooks and I have met with Weichel's attorney, Michael Ricciuti, who is representing Weichel pro bono and believes him to be innocent of the murder of LaMonica. Mr. Ricciuti presented us with some very compelling evidence supporting his belief that the eyewitness identification of Weichel, made by Mr. John Foley, is not credible. I say, "is" in the present tense because back in 1981 when Weichel was convicted, the science regarding eyewitness identifications was not what it is today. Just as DNA technology has proven many convicted felons to be innocent, so too I believe will a reexamination of eye witness identification convictions in light of what we know now compared to what we knew years ago. I would also add that the very manner in which we now conduct photo arrays with eyewitnesses has evolved over the years and new safeguards are now in place to prevent unreliable identifications.

I don't claim to be an expert in eyewitness identification, but I have been walked through the trial of Weichel by Mr. Ricciuti and have spoken at length with Chief Brooks, who lectures nationally on behalf of the Innocence Project regarding eyewitness identification. I have read Chief Brooks' letter to you, dated August 27, 2013 and have serious concerns regarding Weichel's involvement in LaMonica's murder. I agree with Chief Brooks that the identification of Weichel by John Foley is not reliable and I urge you to take some action that will allow Weichel's conviction and John Foley's identification of Frederick Weichel to be reviewed based on today's technology and understanding of eyewitness identification as opposed to that of over thirty years ago.

It is my understanding that motions during the original trial of Weichel to bring in an expert on eyewitness identification and to have the jury view the area where Weichel was allegedly seen running from the murder scene were denied by the court. I am confident that if you were to join me in viewing this area under the conditions that John Foley found himself in the early morning hours of May 31, 1980 that you too would agree that such an identification would be impossible.

"In Partnership With Our Community"

I would also suggest that, to a lay-person like myself, the Memorandum of Law in Support of Defendant's Motion for New Trial Pursuant to Mass. R. Crim. P. 30(b), recently filed by counsel for Frederick Weichel, raises several questions beyond the eyewitness identification that cause me to question Weichel's guilt.

I appreciate your willingness to meet with Chief Brooks and me at your office this past June and our on-going conversations regarding this very serious matter. I also appreciate the dynamics of our request to reopen this case, but truly believe that if you take a critical look at the evidence before you, you too will be convinced that the identification of Fred Weichel is unreliable and should not be used as a basis to convict him for the murder of LaMonica.

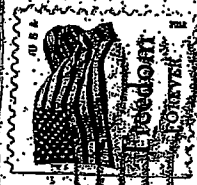

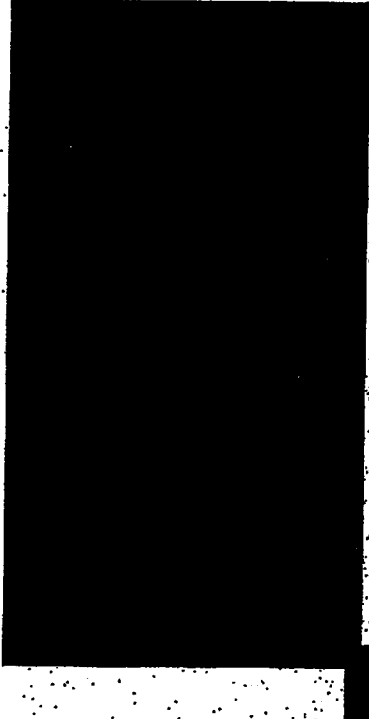

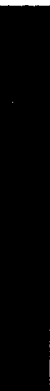

Frederick Weichel has spent 32 years in prison proclaiming his innocence, as the state's highest court rejected his claims that notorious gangster James "Whitey" Bulger helped frame him for a 1980 murder.

Now, a new team of lawyers, assisted by the New England Innocence Project, say they have uncovered evidence that proves Weichel was wrongfully convicted of gunning down Robert LaMonica outside the victim's Braintree apartment. They are urging the court to order a new trial.

Hope they are successful - he is innocent!
STATE AND FED SHOULD DO ALL IN THEIR POWER TO KEEP HIM
"I think Bulger had a role in making sure Weichel took a fall," said attorney Michael D. Ricciuti, a partner in the Boston law firm K&L Gates, which is representing Weichel free of charge. "We're not saying that Fred was a choirboy. We're saying he didn't commit this murder. . . . This goes back to simple justice."

Ricciuti said a federal prosecutor recently disclosed that Bulger's partner, Stephen "The Rifleman" Flemmi, confirmed Bulger warned a corrupt FBI agent who could have provided an alibi for Weichel at the time of the slaying not to get involved in the case.

S.F.'s also said he helped him with murder
Flemmi's claim supports affidavits filed years ago by two other former Bulger associates — Kevin Weeks and Patrick Nee — who allege Bulger urged the agent, John Conolly Jr., not to tell authorities that he saw Weichel in a Boston bar some 15 minutes before LaMonica was shot to death miles away in Braintree.

In addition, according to Ricciuti, Braintree police turned over a document in 2010 — never shared with Weichel's defense during his 1981 trial — that suggested another man had been identified as a possible suspect in the slaying.

David Traub, a spokesman for the Norfolk district attorney's office, said prosecutors received Weichel's motion for a new trial, the third one he has filed, and the Norfolk Superior Court has given them until Nov. 25 to file a response.

"The materials are being reviewed and compared to the large body of existing evidence given at trial and during hearings on the previous unsuccessful motions for new trial," Traub said in a statement.

LaMonica's 86-year-old mother, Marie, said she was convinced that Weichel, now 61, killed her son and that an accomplice remains free.

"This is just another thing to cause a lot of trouble," she said Wednesday in a brief telephone interview. "He's guilty as sin."

A teenager who heard the shots fired at 25-year-old LaMonica and saw a man flee and jump into a waiting car helped police create a composite sketch of the suspect. When shown a photo array, the teenager picked a mugshot of Weichel, of South Boston, as "a pretty good likeness."

Later, while driving around South Boston with police and LaMonica's two brothers, the teenager identified Weichel on a street corner. Weichel was convicted the following year and sentenced to life in prison.

Riccinti, however, said that while reviewing Braintree police reports made available after a public records request last year, he learned that police had received a tip from an informant in 1980 identifying the composite sketch of LaMonica's killer as Rocco Balliro. He had been released from prison on furlough the day before the slaying and died for months.

At the time, police showed the composite sketch to some 10 corrections officers, who all concluded it looked like Balliro, according to the police reports. Balliro died last year.

Riccinti said police were required to share the documents with Weichel's lawyer.

In 2004, Weichel was granted a new trial on the basis of a 1982 handwritten letter purportedly written to Weichel's mother by a former friend, Thomas Barrett, of South Boston, confessing that he had killed LaMonica.

Weichel said Bulger and Flemmi had visited him repeatedly and threatened to kill him or his family if he implicated Barrett in the slaying, and so he told his mother to keep quiet about the letter. It did not surface until after her death.

The state Supreme Judicial Court reversed the ruling in 2006, writing that "the evils and wrongdoing of Bulger and Flemmi are not legally relevant" and that Weichel had made a calculated decision not to release the letter earlier and it was not new evidence.

In February, Assistant US Attorney Brian T. Kelly, sent a letter to Riccinti saying Flemmi "has no memory of ever being present at any meeting" where Bulger threatened Weichel or told him not to bring up Barrett's name in connection with LaMonica's slaying. **TRUE**

However, Kelly wrote that Flemmi recently indicated he was present when Bulger told their FBI handler, Connolly, "don't get involved" in Weichel's murder case. **ALIE**

The admission supports affidavits filed by Bulger associates Nee and Weeks, who say Connolly saw Weichel at The Exchange, a bar on Milk Street in Boston, shortly before LaMonica was killed. Weichel said he left The Exchange just after midnight, then went to Triple O's, a South Boston bar frequented by Bulger, at about 12:15 am — the same time LaMonica was slain.

Weeks testified at Weichel's 1981 trial that he saw Weichel at Triple O's.

Weeks and Flemmi were key witnesses for the government against Bulger, who was convicted in August of participating in 11 murders while running a sprawling criminal enterprise. During the trial, a former drug dealer who worked for Bulger testified that Weichel helped him extort rent payments from marijuana dealers in the late 1970s.

Many religious people out there want to save my soul and get me into Heaven. Received Bibles, prayer cards & Suggestions. All well meaning people but I'm not one for organized religions message - hasn't done much to stop wars or crime.

Its been a long time since our last meeting have had different conversations with Fred way back. First time a friend of his "Donny Mc G." asked me to talk to a Franny Gibbons to get him & his friends to back off from bothering a young guy¹ because of his being related to some one they had issue with² - I did talk to them.

Well they got into a partnership with a trusting soul who had a bar in Nantasket Beech and decided to dissolve partnership by way of Atty Smith & Wesson.

Not a nice thing to do and not a popular thing to do - its no secret the son came down the club on O street & 3rd and asked me if he could go to work for me - right out of a Class B. Movie he offers to work as a "Hit Man" I laughed in his face- Who needs one? He proceeds to give me his resume - "verbally" and I threw him out.

I had problems with that family- his father was a real creep - he was a brick layer handy man for years - reputation for taking \$ money up front to repair stairs etc. and drag his feet and demand more \$ if he was to continue job. I'd given him a hard time over it and he didnt like it.

That chapter is closed - I seek no revenge and would do nothing to change the Deal they have made - it would require me to testify - never have and never will. Overtures have been made for me to discuss such as who was in car with me? State interest plus other issues. I Decline even declined the interview the other day by members of the Court regarding pre sentencing Report.

This has been a complex trial and a set up - the Titanic was sinking and these passengers had dangled in front of them escape from certain death - Price for seat in life boat too steep for me.

I had 2 paid informants in the FBI - one from the project the other his boss¹ - well said - unknown to me to cover themselves and to enhance thier careers they created a file - a file I didnt have any knowledge of until 2011 when I got here in this jail and

Looking back, I met [REDACTED] on Fridays gave him money to get by on - he was a young guy in the project I gave him good advice knew he a target of car bugs etc and even an innocent statement can be twisted.

If I told J.C. to back off K.W. has been around for years why did he wait so long to tell this story - a dumb move on his part he ratted on J.C. and helped get him 40 years - this lie will not endear J.C. rather will only infuriate him.

Mention of the 2 of them around demonizing me with this lie really upsets me to no end. I enter this with hope for an innocent person put my self up for more adverse publicity - more media attacks that cause pain for innocent people in my family.

Read letter to Atty Riccuiti and agree whole heartedly with audi visual deposition in regards to what I know regarding the innocence of Freddy W.

I feel my message to individual un-named making him aware that Im no longer a threat to him in any capacity - I know for years he kept silent because of my parting threats to him - he feared for his life if he dared implicate me in his action against a person he was afraid of - a person who advertised he killed and intended to kill - un named -

He wanted my advice, we sat down in the Transit - Triple Os Cafe told me he had a fight with a person and roughed him up quite badly & a friend of his was out to kill him - he & his father - both deceased - had killed a person at Nantasket Beach. Talk of the town and the son felt he was on a roll to rack up some Hits.

This young killer had come down to a club we had on O St in South Boston - all dressed up shirt tie & suit & shoes shined - looked like he was ready for Sunday Mass. He introduced him self to me and said I want to Work for You! Asked him "Doing What?" Very serious like hes in an office seeking a job as clerk! - tells me I want to be a Hit Man!

I laughed told him what would I need you for? And trying to lighten him up said why should we bring you aboard to share the Fun - could see this guy was serious ushered him out. But recognized hes serious and wants a career of killing - felt the Power of the Gun.

Took this into consideration when advising un-named - told him I know - met him and hes determined to hurt people - he [not legible] have 2 options - 1st able to hurt people with his hands - defeat them in a fight 2nd option he knows works and he likes the feeling and wants the Reputation.

I advised un named - if he said alls forgotten - he may be setting you up it's a gamble and if he moves on you its over. "What would I do" I told him get him first, kill him, then theres no Rd 2¹ if you dont get him first Id say he will get you - hes dangerous - so again Kill him and its over. And also Never - Never repeat this conversation to Any One - my only warning - you know what will happen if you do - He understood -

Soon Jr Killer is Retired - his career over - had he went on others would have been killed - as far as Im concerned un named - case of Self Defence.

Sadly young guy² swept up railroaded into life sentence - know un named & innocent³ were friends. If un named never told about me and our conversation it was out of fear - had he Id probably been named in some capacity.

My only thing is if he decides to want to help his friend hes free of my threats - and his lawyer should be able to get him a good deal - one witness against me for his testimony against me and confession of 20 murders he committed had to serve only 6 months for each and given \$20,000 cash on release - hes been free for years.

Another involved in 5 murders testified for Gov and his 5 years - so he should be able to do well for him self and free his friend - his innocent friend. He will be telling the Gods Honest Truth - the above Gov. Witness Lied on some thing & true on others - I never defended my self

Kevin Weeks & Pat Nee now theres a duo who would never tell a lie - "The Truth" if it were told would end thier careers. KW failed polygraph and pros.² got part that because he was in thier game.

Shocked to see Fred says I helped frame him. Freddy has Weeks & Nee in his corner they should be able to enlist the help of Wyshak - he has done much for them and they reciprocate. The story about me telling John C. to back off was a tactical error - K.W. helped hang him "40 yrs worth" - Im sure that story was told to Fred after Weeks rolled over - he wants to get good will from any one in the Town as does his co-conspirator P.N.
